This is a voluntary announcement made by Greentech Technology International Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) announces the total production summary of Rension Project of Bluestone Mines Tasmania Joint Venture Pty Limited (the “**BMTJV**”) in which YT Parksong Australia Holding Pty Limited (“**YTPAH**”) owns 50% shareholdings, for the quarter from October to December 2021 (the “**Quarter**”). Physical outputs for the Quarter are summarised below with corresponding figures for the previous quarter (i.e. from July to September 2021):

Note: Recovery is expressed as overall recovery, taking account of losses of tin through the ore sorter and the concentrator.

Tin production for the quarter decreased by 4.5% to 2,359 tonnes. The grade of ore mined for the quarter increased by 0.08 percent point to 1.58%. The average quarterly recoveries for the quarter decreased by 2.8 percent points to 76.7%.
