**VOLUNTARY ANNOUNCEMENT –
PUBLIC CONSULTATION COMMENCED FOR
RENTAILS TAILINGS RETREATMENT PROJECT**

This is a voluntary announcement made by Greentech Technology International Limited (“**Company**”, together with its subsidiaries, the “**Group**”). References are made to the voluntary announcement made by the Company dated 16 January 2023.

The board of directors of the Company is pleased to provide an update on previous studies at the tailings retreatment project (“**Rentails**”). Rentails is part of the Renison tin operations managed by Bluestone Mines Tasmania Joint Venture Pty Ltd (“**BMTJV**”), in which YT Parksong Australia Holding Pty Limited (“**YTPAH**”), an indirect non-wholly owned subsidiary of the Group, has a 50% equity interest. Metals X Limited, a company incorporated in Australia with limited liability and the shares of which are listed on the Australian Securities Exchange (“**ASX**”), owns another 50% equity interest in Renison though its 50% stake in the BMTJV.

BMTJV is currently updating previous studies at Rentails at the Renison tin operation in Tasmania, Australia with the intention of finalising a definitive feasibility study (“DFS”) and environmental permitting within the next two to three years, to facilitate an investment decision by BMTJV.

To ensure the project is compliant with all necessary Tasmanian regulations and environmental standards, BMTJV must submit an Environmental Impact Statement to the Tasmanian Environment Protection Agency, and an associated Development Application to the West Coast Council. In parallel, it will refer the project for Commonwealth Environment Protection and Biodiversity Conservation assessment.
